CALIFORNIANS FOR ALL ROUND 1 FUNDING NO-COST TIME

EXTENSION UNTIL DECEMBER 31, 2024

EFFECTIVE DATE

This directive is effective upon the date of issue.

PURPOSE

The purpose of this directive is to officially announce a three-month extension to the California for All (CFA) Round 1 Program and a "no-cost time extension" for all programs funded through the (CFA) grant. This extension will extend the performance period from October 1, 2024 to December 31, 2024.

BACKGROUND

In Program Year (PY) 2021-22, the City of Los Angeles (City) was awarded \$53.3 million in funding through the Office of the Governor's California Volunteers to expand youth workforce development programs through the CFA initiative. This initiative provides transitional work and additional employment-based social services to youth between 16 and 30. In partnership with multiple City departments, including the Department of Public Works (DOPW), Recreation and Parks (RAP), Youth Development Department (YDD), and Community Investment for Families Department (CIFD), the City has continued to recruit, train, and place high need youth at jobs in a variety of youth workforce development programs.

The timeline to expend funds was initially extended from June 30, 2024, to September 30, 2024. The Mayor's Office of Economic Opportunity (MOEO) secured an additional time extension that will extend the timeline to December 31, 2024.

Agencies should continue with regular youth services associated with all CFA programs, including the enrollment of new program participants, if applicable. The Economic and Workforce Development Department (EWDD) is working to execute amendments to all relevant contracts included in this time extension within 10 days of this notice.
