



## NEWS FOR THE WEEK OF JUNE 1, 2020

EWDD's mission is to serve the City of Los Angeles' underserved populations and small business owners. As protests unfold in the region, EWDD's WorkSource, BusinessSource and YouthSource Centers remain committed to assisting Angelenos in navigating the new normal ushered in by the devastating economic impacts of COVID-19

Nearly one million people were unemployed in April, according to new metrics recently released by the California Employment Development Department (CA EDD). These numbers are reflected in the City's April Workforce Metrics, which show approximately **24,633 Angelenos registered for services at EWDD's WorkSource Centers**, representing a **78 percent increase** from the previous month.

EWDD's Rapid Response Team has provided **1,894 virtual training sessions** since mid-March. Offered in English and Spanish, the trainings help Angelenos navigate the process of filing Unemployment Insurance (UI), and connect with other resources. Recent reports indicate that **563 businesses**, some with multiple locations, have closed in the City of LA during this health crisis, impacting roughly **101,219 employees**. EWDD's WorkSource Centers continue to work tirelessly to assist Angelenos whose livelihoods were impacted by COVID-19.

EWDD's Economic Development Division continues to work non-stop to process loan applications. Loan Requirements were recently eased to allow greater access to the program. This week, we share a story from a Valley Village cross-fit business that received a Small Business Emergency Microloan that allowed them to pay a large portion of their commercial rent, and retain three full time employees and one part time employee.

**Helping Small Businesses Survive COVID-19****NORTH VALLEY BSC HELPS CROSSFIT BUSINESS RECEIVE MICROLOAN****Angelino Crossfit**

The North Valley BusinessSource Center helped Angelino CrossFit owners Karlos Ramirez and John Thyne obtain funds from the City of Los Angeles Small Business Emergency Microloan Program, which allowed them to pay a large portion of their commercial rent and retain three full time employees and one part time employee. These funds will not only help them with payments, but also ensures that there will not be a delay in opening two more locations in the future. John learned about the North Valley BSC through a flier distributed by the Neighborhood Council Valley Village, where he currently serves as a board member. Since closing their doors on March 15, 2020, Karlos and John and other CrossFit coaches have been providing their members with daily “Home Workouts” through their app “Wodify,” on Instagram, Facebook and Zoom sessions. Many of the members have continued to pay their membership fees and others

have also paid for the memberships of other members. The team has also lent out 90 percent of the gym’s weights and equipment so that their members can continue to work out at home.

**CD 3 AND EWDD LAUNCH FOOD & BEVERAGE INDUSTRY WORKING GROUP**

EWDD and Council District 3 kicked off the first meeting of the Food and Beverage Industry Working Group on Thursday, May 29, 2020. Councilmember Bob Blumenfield provided introductory remarks, while Small Business Commissioner Mott Smith moderated the meeting. More than 40 people virtually attended, including leaders from LA’s Food and Beverage Industry, along with representatives from multiple City Departments. The group’s goal is to develop recommendations for low-cost or no-cost changes that will streamline City processes and modify regulations. These updates will allow establishments to reopen while following COVID-19 health guidelines. The group was established per Council File 20-
